Upon accepting the position offered on any OCSS-Seminole or Academy Team, the **guardian/s of player** are responsible for Club fees/payment plan as agreed to in Playmetrics during online registration, all team fees as budgeted and posted in Snap Spend, all OCYS Financial Policies, parent and player are responsible to maintain all policies and conduct outlined in the OCYS Policies & Pledges.

A player will not be granted a release from OCSS-Seminole until all Club and Team fees are paid in full and the player is in Good Standing with OCSS-Seminole.

Club Fees: Paid to the club. Full payment or payment plan selected and agreed upon at time of registration.

Team Start-Up Fee: \$150 (payable to Team, per team manager/coach) due at team meeting. The initial payment from each player is to open the Team's bank account and make payments for tournament registrations.

Team Fee: An Additional monthly fee may be required from each player to cover team expenses (tournament registrations, 2nd tier league referee fees (1st tier paid by club), coach's travel expenses, etc., not covered by the initial Team Start-Up fee. The monthly amount is determined after the players have accepted a position on the team and the number of tournaments/travel plans has been determined.

OCSS-Seminle Uniform Kit: Purchased from UWS. Full kit including 2 game jerseys, 2 game shorts, 2 game sock sets, 1 training jersey, 1 training short, 1 training sock set, 1 warm-up (jacket & pant), and 1 back pack; approximately \$400-\$454 depending on size. Kit without warm-up, approximately \$300, depending on size. The kit changes every 2 years; 2023/24 Season will be the first year of the cycle. Not in included in club fees.

OCSS-Seminole/Parent Agreement Terms, effective on June 10th, 2023 – or completion 2023 FYSA State Cup* *ECNL/RL – no player can be dropped from an ECNL/RL roster during the seasonal year – August 31st – July 31st.

We fully understand and consent to the following terms and conditions regarding OCSS-Seminole fees as outlined in the Fee Sheet and the estimated budget provided by each individual team coach/manager as well as OCSS-Seminole membership conditions and privileges as stated in the Financial Policies and Policies and Code of Conduct.

- 1. We agree to register as a member of the OCSS-Seminole seasonal year program 2023-2024.
- 2. We are responsible for the entire season's Club Fees and Team Fees. OCSS-S may, in its sole and total discretion, offer a payment plan for Club Fees and/or Team Fees however such option in no way waives any obligation for full payment of all sums due for such Club Fees and/or Team Fees.
- 3. We understand and agree to possible additional Player/Family **travel expenses**. The amount varies depending on the mode of travel, hotel and meal expenses incurred by the player/family for each tournament and/or league play. These expenses are the personal responsibility of each player/family.
- 4. Failure to pay the Club Fees and/or Team Fees by the applicable due dates established by OCSS-S may, in the sole and total discretion of OCSS-S, result in suspension of membership, in addition to late fees as set forth below.
 - a. I understand that, under the payment plan agreement, a \$25 late fee will be assessed to my Club Fee account invoices for any Club Fee and or Team Fee payments not received within thirty (30) days of the due date set forth on the OCSS-S Fee sheet. *Payment Plan agreements of two installments or more include credit card services fees on each installment.
 - b. I also understand that the player may be suspended from OCSS-S training, games and activities if payment for Club Fees and/or Team Fees is not received within 60 days from the due date set forth on the OCSS-S Fee sheet and/or the Team Fee payment schedule.

- **5.** A \$200 release fee must be paid prior to any release request's approval. Season ending injuries and move beyond 100 miles are exempt.
- 6. If we withdraw, are suspended or are terminated from OCSS-S program for any reason whatsoever, we acknowledge that we are not entitled to any refund of Club Fees and/or Team Fees previously paid, and we shall remain responsible to OCSS-S and the Team for the entire year's fees.
- 7. Financial Aid will be revoked and due upon any release request other than a season ending injury or move beyond 100 miles.
- **8.** If we default in payment of our Club Fees and/or Team Fees for any reason whatsoever, we are liable for all costs and expenses incurred in collecting the same, including, but not limited to reasonable attorney's fees, collection fees and court costs.
- **9.** We understand that the selection and team placement of players shall be at the discretion of OCSS-S Academy Directors and Coaches.
- **10.** We agree that the continued participation of a player is contingent upon the player and his/her family continuing to adhere to the rules, agreements, OCSS-S Financial Policies, OCSS-S Policies & Pledges and this contract.
- 11. We agree to participate in the Club Community Service Program. Each family agrees to complete a minimum of 5 hours in the upcoming Seasonal Year. Community Service opt out is a \$50 fee.*
 *ECNL families are not permitted to opt out of Community Service due to ECNL required staffing at our Sanford National Event.
- **12.** We have read and agree to the OCYS Financial Policies and OCYS Policies & Pledges, available under Resources and Forms on ocyouthsoccer.com.
- **13.** International Clearance fee is \$75 per player
- 14. 15 volunteer hours are required for each club member. This can be split between the family members. You can opt out of volunteer hours by paying the \$150 volunteer opt out fee.
